Secretary's Report:

Approval of January 4th Minutes: Steve Wallace made a motion to accept. 2nd by John Leavitt. All in favor by verbal vote.

Treasurer's Report: Current balance is \$25,890. John Leavitt made a motion to accept the Treasurer's Report. 2nd by Misty Guild. All in favor by verbal vote.

Updates from AAG Andrew Black:

Complaint Officer Report: No complaints at this time.

Kickboxing update: Chris Guild spoke with the ME Dept of Economic Development in regard to the fees to clarify the fees are not changing, we are just adding kickboxing and Muay Thai. Committee on Housing and Economic Development have assigned LD 271 for Kickboxing LD 272 for Muay Thai and are just waiting Legislative approval. March 8 is the final review date for kickboxing rules.

Muay Thai: Chris Guild spent time today comparing our Muay Thai rules and the most recent version of the Unified Rules. It seems we should be able to streamline

our rules and align them. Chris Guild and Steve Wallace will continue working on those.

Boxing: Chris Guild and John Leavitt will work together to amend the boxing rules.
