The solutions include: high visibility of check in procedure, security in place to keep the scale area clear and ready to go at noon (checking weights is still acceptable). Encouraging the fighters/corners to register beforehand and a late arrival statement has been added to the fighter contract stating that the fighters need to arrive on time or they will forfeit money from their purse. Jon Pinette made a suggestion to have conversation about what the language for late arrival might look like for amateurs since they do not have a contract. Everyone agreed to see how this works at these fights and move forward from there. The weigh ins will be held on May 2 at 12:00 pm at SeaDog Brewing in Bangor Maine.
